

**SUMMARY ANNUAL REPORT FOR THE  
LOCAL NO. 8 IBEW RETIREMENT PLAN AND TRUST**

**TO ALL PARTICIPANTS**

This is a summary of the annual report for the Local No. 8 IBEW Retirement Plan and Trust, I.D. #34-6596899 for the Plan year beginning January 1, 2008 and ending December 31, 2008. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 [ERISA].

**BASIC FINANCIAL STATEMENT**

Benefits under the Plan are provided by Trust Investments. Plan expenses were \$13,157,985. These expenses included \$1,511,433 in administrative expenses and \$11,646,552 in benefits paid to participants and beneficiaries. A total of 2,443 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of Plan assets, after subtracting liabilities of the Plan, was \$218,524,074 as of December 31, 2008, compared to \$282,146,516 as of December 31, 2007. During the Plan year, the Plan experienced a decrease in its net assets of \$63,622,442. This decrease included unrealized depreciation in the value of Plan assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The Plan had total income of \$(50,464,457), including employer contributions of \$14,890,191, losses from investments of \$(65,363,960), and other income of \$9,312.

If you request a copy of the full annual report from the Plan Administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover the copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the Plan Administrator, 727 Lime City Road, Rossford, OH 43460, and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
