SUMMARY ANNUAL REPORT FOR THE LOCAL NO. 8 IBEW RETIREMENT PLAN AND TRUST

TO ALL PARTICIPANTS

This is a summary of the annual report Form 5500 Annual Return/Report of Employee Benefit Plan for the Local No. 8 IBEW Retirement Plan and Trust, I.D. #34-6596899 for the Plan year beginning January 1, 2023 and ending December 31, 2023. The Form 5500 annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 [ERISA]. Your plan is a defined contribution benefit plan with participant directed investments, including a 401(k) feature.

BASIC FINANCIAL STATEMENT

Benefits under the Plan are provided by Trust Investments. Plan expenses were \$32,099,641. These expenses included \$2,234,407 in administrative expenses and \$29,865,234 in benefits paid to participants and beneficiaries. A total of 2,833 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of Plan assets, after subtracting liabilities of the Plan, was \$596,389,019 as of December 31, 2023, compared to \$534,273,900 as of December 31, 2022. During the Plan year, the Plan experienced an increase in its net assets of \$62,115,119. This increase included unrealized appreciation in the value of Plan assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The Plan had total income of \$94,214,760 including employer contributions of \$18,169,682, participant contributions of \$5,106,709, and income from investments of \$70,938,369.
